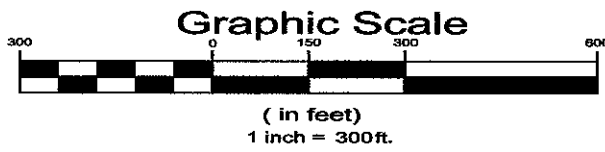

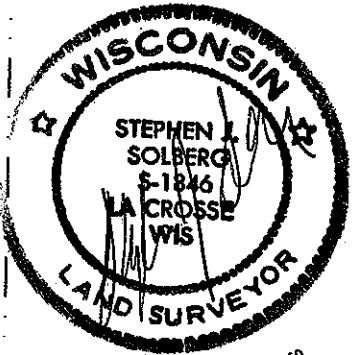
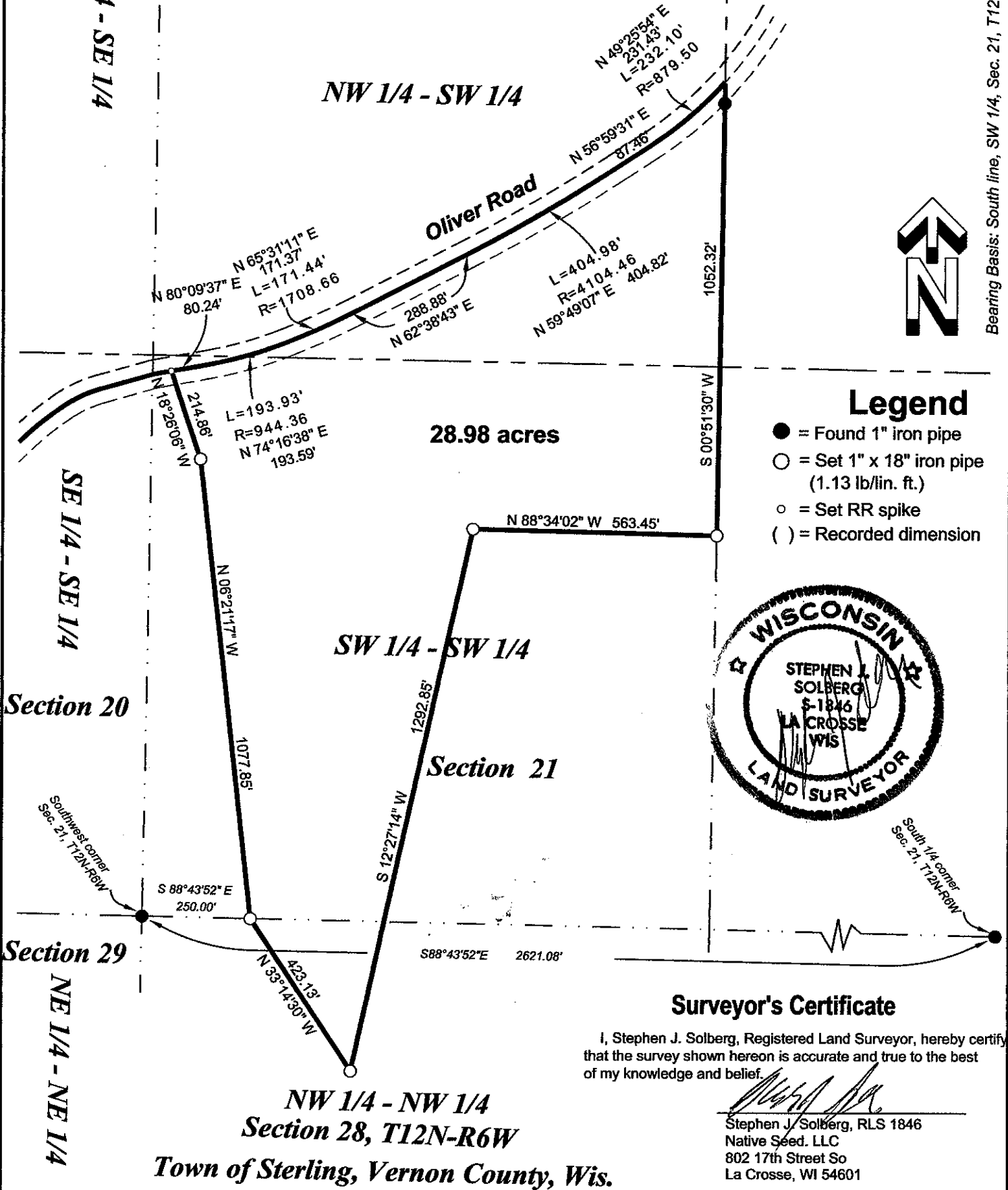

# Description

Part of the NW ¼ of the SW ¼, the SW ¼ of the SW ¼, Section 21 AND part of the NW ¼ of the NW ¼, Section 28, all in T12N-R6W, Town of Sterling, Vernon County, Wisconsin, described as follows:

Commencing at the southwest corner of said Section 21; thence along the south line thereof, S 88°43'52" E 250.00 feet to the point of beginning;  
thence N 06°21'17" W 1077.85 feet;  
thence N 18°26'06" W 214.86 feet to the centerline of Oliver Road;  
thence along said centerline, N 80°09'37" E 80.24 feet;  
thence continuing along said centerline, 193.93 feet on the arc of a 944.36 foot radius curve, concave to the north, the chord of which bears N 65°31'11" E 171.37 feet;  
thence continuing along said centerline, N 62°38'43" E 288.88 feet;  
thence continuing along said centerline, 404.98 feet on the arc of a 4104.46 foot radius curve, concave to the northwest, the chord of which bears N 59°49'07" E 404.82 feet;  
thence continuing along said centerline, N 56°59'31" E 87.46 feet;  
thence continuing along said centerline, 232.10 feet on the arc of an 879.50 foot radius curve, concave to the northwest, the chord of which bears N 49°25'54" E 231.43 feet to the east line of said NW ¼ of the SW ¼;  
thence along said east line and east line of said SW ¼ of the SW ¼, S 00°51'30" W 1052.32 feet;  
thence N 88°34'02" W 563.45 feet;  
thence S 12°27'14" W 1292.85 feet;  
thence N 33°14'30" W 423.13 feet to the point of beginning.
